# e. General Service Update

Chief Lawson updated the Board on the development of a new Police facility with three potential building sites. The Chief has met with the architects to determine the needs of the Service.

The Chief advised of dimishing service levels from Integrated Units (RDVU, MYST and IMCRT) without joint management teams or MOUs. The Area Chieffs are now in review of the MOUs of other integrated units.

Police Camp wil occur again this year in March with Cst. Gentile as a Team Leader. Response to this event was very well received with over 200 applicants for 50-60 spots.

Cpl. Bryant has raised \$11,000 for Wounded Warriors in his fund raising efforts.

At this time, the Service has received 25 applicants for a new recruit for a May intake. A professional recruitment video is currently being developed and filming will begin in early spring 2025.

The CSPS boat is being shipped to Richmond for pick up, the Service hopes to have it in the water in the Spring.

GGVAF funding is currently being secured for 2025.

Board Member Riddell asked about the potential increased funding for the MYST integrated, Chief Lawson advised that funding/cost was not the only reason for the Service's departure from the unit. He had not heard anything about federal funding for the unit.

Deputy Chief Hackett presented the monthly stats.

# f. Financial Update

No updates at this time. The next update will likely be expected in April. The CFO, Troy Ziegler, has left his post with Central Saanich and the position is currently vacant.
